

**For Immediate Release****J.O. Pharma Co., Ltd. to construct a new manufacturing facility for prefilled syringes (a syringe with injectable drug solution filled in advance):  
Signing of an agreement with Shimane Prefecture and Izumo City  
for the facility construction**

Tokyo, November 28, 2011 — J.O. Pharma Co., Ltd. (Head office: Izumo, Shimane, Japan; President: Kazuma Yuasa), a consolidated subsidiary company of Otsuka Holdings Co., Ltd. (Head office: Tokyo, Japan; President and Representative Director, CEO: Tatsuo Higuchi), announced today that it concluded a “Memorandum of agreement” with Shimane Prefecture and Izumo City for the construction of a new manufacturing facility to increase the production of prefilled syringes. The new facility is to operate in May 2013.

“Prefilled syringe” is a ready-to-use kit product that a drug solution is aseptically filled in a syringe in advance. Unlike conventional preparations packaged in containers such as ampoules or glass vials, the drug solution does not need to be transferred from the ampoule or vial to the syringe at the time of administration. Demand for such prefilled syringe is constantly on the increase in clinical settings. Prefilled syringes offer advantages in the administration of injectables, including a reduction in bacterial infection and particle contamination, prevention of medication errors, and speedup and time savings for drug preparation.

J.O. Pharma Co., Ltd. is a joint venture company established in 2003 between Otsuka Pharmaceutical Factory, Inc. (Head office: Naruto, Tokushima, Japan; President: Ichiro Otsuka), a wholly owned subsidiary of Otsuka Holdings Co., Ltd. and JMS Co., Ltd. (Head office: Hiroshima, Japan; President: Hiroaki Okukubo).

**Signing of Memorandum of agreement:**

Today, with expectations for growth of local economy and creation of jobs, “Approval letter for facility establishment plan” has been given to J.O. Pharma Co., Ltd. by Shimane Prefecture according to the Shimane prefectural ordinance for promoting new business establishment, and “Memorandum of agreement” for the establishment of manufacturing facilities has been concluded by the three parties, Shimane Prefecture, Izumo City, and J.O. Pharma Co., Ltd.
